#### **Council Meeting Minutes**

November 15, 2022

Present: Les Barker, Vice President; Diana Frye; David Stein; Toby Theis; Suzie Vagedes; Ric Warner, President. Meeting was called to order by Ric Warner. Silent opening prayer.

Secretary's Report: Minutes were approved as written. Motion: Les Barker, Second: David Stein. All were in favor.

**Financial Secretary's Report:** Motion to approve as written: David Stein, Second: Les Barker. All were in favor. Toby Theis stated that there were 28 pledge cards returned, 3 of these were new givers; of the current givers who pledged, 17 givers increased their gift! He is contacting any regular givers from last year that have not returned an Estimate of Giving Card (approximately 11 givers).

Treasurer's Report: Motion to approve: Suzie Vagedes, Second: Toby Theis. All were in favor. Pastor's Report: Ric Warner read Pastor Peter's notes:

Suggested that for All Saints Day in the future everyone should re-submit the Saint's names annually.
Christmas Eve Service will be at 8pm. (Council agreed that we would not have a Christmas Morning Service since Christmas Eve Service is Saturday night.)

3. Requested that we hold a training day for the AED. (We will check to see who we might know that would be credentialed to teach the class; possibly Rusty Baker or Beth Ewing.)

4. Preschool asked if GSLC would want to increase the Preschool's rent due to increased use of utilities and space. (Council agreed that we did not wish to increase their rent.) Preschool also discussed doubling the amount of the loan repayment per month for the playground equipment. (It was agreed that Council did not want to over burden the Preschool financially and was not seeking double payments, but would abide by what the Board decided). Preschool Christmas party is on Wednesday, Dec. 14, from 9am to noon. They are asking for volunteers. **NEW BUSINESS**: Consecration Sunday- Ric Warner thanked Suzie Vagedes for her work on Stewardship planning and the Consecration Sunday event.

Church office computer- The hard-drive failed this week. Ric Warner received a quote for the new computer \$900.97. This includes new computer: *HP 12th Gen core i5 8gig ram 512 SSD drive Windows 11 Home Bluetooth and Wi-Fi 6*; Antivirus for 1 yr; set up; and first month of Back Blaze data service \$25/ month. After some discussion, Dave Stein motioned to use the Capital Reserve fund to pay for the new computer, antivirus and set up, but to drop the Back Blaze data service. Toby Theis seconded. All were in favor. It was also agreed by all that the new computer would be password protected to limit usage in the future.

Coats purchase request- Judi Gilbertson requesting money for buying new and gently used coats for the homeless served by First Lutheran in downtown Dayton. After discussion Diana Frye motioned to take \$250 from the Kroger fund for the purchase of the coats. Suzie Vagedes seconded. All were in favor.

Air Purifiers- Preschool Director, Becky Garret has received a grant to pay for UV Light Air Purifiers and asked if GSLC would agree to have them mounted in the Preschool areas. GSLC's only expense would be paying the electric bill. More information coming soon. Item tabled until then.

**OLD BUSINESS**: 5-Year Plan – Ric Warner asked to have a poster made of the 5-Year Plan and placed prominently. Suzie Vagedes will ask Amy Grile to make a small mock-up and Les Barker will have it enlarged on a poster.

Pastor search – Ric Warner will be contacting Bob Abrams regarding the increased urgency of finding a suitable pastor candidate due to Pastor Peter's pending retirement.

5. Pastor Peter will retire on December 31.

#### **Council Meeting Minutes Continued**

#### **Committee Reports:**

Worship: Ric Warner will forward Marsha Fischbach's worship report: briefly there will be bellringers at the Christmas Eve Service. More singers are wanted for the Christmas musical, and Darrell Fryman is being asking to take the full-time pianist position. Marsha and Ric drew up a contract for the position for Darrell to sign. Motion to approve both the contract and the hiring of Darrell Fryman for the pianist position was made by Toby Theis. Diana Frye seconded. All were in favor.

Mission/Outreach/LSIM/MUCC: MUCC - Les Barker reported that the Community Thanksgiving service would be held on November 23, 2022, at the Center Friends Church. Welcome bags were well received in the Stillwater Crossing neighborhood on Saturday, October 22. No visitors from the neighborhood yet, but possibly for Christmas. Christmas food baskets will be distributed on December 9 with packing being done on the 7th and 8th. Diane Frye reported that LSIM will meet at GSLC on Tuesday, Nov 29.

Property: The outdoor lights have been (mostly) fixed. The LED lights for the sign have been shipped and Les Barker will install them once they arrive. He anticipates having the sign fixed by this weekend. David Stein reported that he hopes to install the cabinets over the Preschool's Christmas break. Les Barker and David Stein requested that we make known that a large shrub is blocking the light shining on the front of the church to see if any members have an objection to removing it.

Youth/Christian Education/Preschool: We are offering a Sunday School lesson during the Sunday service, hoping to grow attendance. Suzie Vagedes will continue to have a lesson ready.

Stewardship: see above

Fellowship: no report

Motion to Adjourn Council Meeting: David Stein, Second: Diane Frye. All in favor. Meeting adjourned with The Lord's Prayer. "Don't fear, because I am with you; don't be afraid, for I am your God. I will strengthen you, I will surely help you; I will hold you with my righteous strong hand."

#### Support Your Church through Your IRA Required Minimum Distribution

Are you over the age of, or approaching 70-1/2 and must take a Required Minimum Distribution (RMD) annually from your traditional IRA? This Required Minimum Distribution (RMD) is taxed as ordinary income.

Why not consider turning some or all of your Required Minimum Distribution (RMD) into a <u>Qualified</u> <u>Charitable Distribution (QCD)</u> to your Church to fulfill all or part of your annual contribution, and/or for a special project? In so doing, the amount donated is excluded from your taxable income keeping your taxable income lower.

Qualified Charitable Distributions don't require you to itemize. Therefore, you may choose to take advantage of the higher standard deduction and still use a Qualified Charitable Distribution (QCD) for charitable giving.

#### To make a Qualified Charitable Distribution, certain requirements must be met:

• You must be  $70\frac{1}{2}$  or older

• The maximum annual amount that can qualify for a <u>Qualified Charitable Distribution (QCD)</u> is \$100,000. Your spouse may also be able to make a Qualified Charitable Distribution (QCD) from his or her own IRA in the same tax year for up to \$100,000.

• Your Qualified Charitable Distribution (QCD) can be made to one or more charities, such as the church, or IHN, or any qualified charity. You may also stipulate how you wish your Qualified Charitable Distribution (QCD) be used by the organization you are supporting such as the Food Pantry or the Youth Program.

• For a Qualified Charitable Distribution (QCD) to count toward your current year's Required Minimum Distribution (RMD), the funds must come out of your IRA by your Required Minimum Distribution deadline, generally December 31. However, it is wise to not wait to make a Qualified Charitable Distribution (QCD) until the deadline date since the IRA Custodian needs time to process your request.

#### Tax reporting

A <u>Qualified Charitable Distribution (QCD)</u> is reported as a normal distribution on IRS Form 1099-R for any non-inherited IRAs. While the Qualified Charitable Distribution (QCD) amount is not taxed, you may not then claim the distribution as a charitable tax deduction.

To accompany your tax form, you will need a letter from the charity detailing that the gift came directly from your IRA custodian and that you received no goods or services in exchange for your gift.

#### Next steps?

Consult your tax or legal advisor. Then notify your IRA custodian you wish to make a Qualified Charitable Distribution (QCD). The Qualified Charitable Distribution (QCD) must be sent directly to the charity by the IRA Custodian. If it is sent to you, it will be considered taxable income.
